II.

III.

#### The following are our objectives:

- 1. Establish and disseminate a standard economic data base information system for the Carparthian region.
- 2. Study, analyze and initiate changes in border crossings of the region to simplify procedures and reduce unrealistic delays for commercial trade.
- 3. Establish free trade zones and bonded areas in each regions.

- 4. Provide a business communication publication specially for the region's enterpreneurs.
- 5. Unite the region enterpreneurs into a dynamic business association and develop the region through our international programs.

In order to reach the aims of the Association and coordinate the work the involved initiators with the regional economic and administrative authorities experts together form the ASSOCIATION COUNCIL consisting of 12 members, 4 persons of each countries. Participants of the CBED Association Council members shall organize their common work and it is the main decision-making body of the Association.

VI.

Additional organizations are allowed to join this present contract in case they have the original signatories' agreement.

VII.

This contract can be cancelled by any of the contracting parties with 6 months notice. The period of notice starts from the first day of the month that the cancellation is posted to the rest of the contractors.

VIII.

The contracting parties empower the Association Council to work out the guiding rules of the operation of the Council and the main office.

IX.

The present contract is in force from signing by the signatories.
